1. Our Vision

The Catholic Church insists on the highest standards of academic achievement in its schools, so that our young people leave us as ‘agents of change’ – educated and caring people who have the qualifications, knowledge and skills they need to flourish as human beings and make the world a better place.

Inspired by our Teacher, Jesus Christ, and his good news to the poor, we have a commitment especially to those who are disadvantaged. We are determined that a child’s start in life need not determine their future. We are committed to the well-being of the earth, our common home, inspired by the example of Pope Francis: to live wisely, think deeply and love generously.

In all our schools we will develop a culture of high expectation and aspiration, based on our fundamental belief in the dignity of all human beings. We want all our pupils to flourish in safe, happy and enriching environments, taught and supported by adults who are skilled, motivated and committed to our shared vision and values.

We will work together as one Trust, one family of schools, a community inspired by a vision for excellence. We commit ourselves to deepen our mission and raise standards in order to provide an excellent Catholic education for every child in our care.

2. The Importance of School Attendance

Improving attendance is everyone's business. The barriers to accessing education are wide and complex, both within and beyond the school gates, and are often specific to individual pupils and families.

Good school attendance for individual pupils is not only critical for the contribution that it makes to strong academic and social outcomes, but also for the habit that it forms for later education, training and employment.

At KS2, pupils who attended school nearly every day in Year 6 (with an attendance rate of 95-100%) were 1.3 times more likely to achieve the expected standard in reading, writing and maths compared to pupils who only attended 90-95% of the time.

This means missing just 10 days of year 6 reduced the likelihood of reaching the expected standard by around 25%.

At KS4, pupils who attended school nearly every day in Year 11 (with an attendance rate of 95-100%) were 1.9 times more likely to achieve the Grade 5 in English and Maths GCSE compared to pupils who only attended 90-95% of the time (relating to up to 2 weeks more time in school over the course of a year) and 3 times more likely than persistently absent pupils who only attend 85-90% of the time (relating to 4 - 6 weeks more time in school).

This means missing just 10 days of year 11 reduced the likelihood of achieving grade 5 in English and Maths by around 50%.

There are clearly demonstrable links between attendance and lifetime earnings. There are also links between lifetime earnings and life expectancy. The foundation of securing good attendance is that school is a calm, orderly, safe, and supportive environment where all pupils want to be and are keen and ready to learn.

Some pupils find it harder than others to attend school and therefore at all stages of improving attendance, schools and partners should work with pupils and parents to remove any barriers to attendance by building strong and trusting relationships and working together to put the right support in place.

Securing good attendance cannot therefore be seen in isolation, and effective practices for improvement will involve close interaction with schools' efforts on curriculum, behaviour, bullying, special educational needs support, pastoral and mental health and wellbeing, and effective use of resources, including pupil premium.

It cannot solely be the preserve of a single member of staff, or organisation, it must be a concerted effort across all teaching and nonteaching staff in school, the trust, Local CAST Board, the local authority, other local partners, and of course pupils' families.

3. The Law on School Attendance

The law entitles every child of compulsory school age to an efficient, full-time education suitable to their age, aptitude, and any special educational need they may have. It is the legal responsibility of every parent to make sure their child receives that education either by attendance at a school or by education otherwise than at a school.

Where parents decide to have their child registered at school, they have an additional legal duty to ensure their child attends that school regularly. This means their child must attend every day that the school is open, except in a small number of allowable circumstances such as being too ill to attend or being given permission for an absence in advance from the school.

This is essential for pupils to get the most out of their school experience, including their attainment, wellbeing, and wider life chances. The pupils with the highest attainment at the end of key stage 2 and key stage 4 have higher rates of attendance over the key stage compared to those with the lowest attainment. At KS2, pupils not meeting the expected standard in reading, writing and maths had an overall absence rate of 4.7%, compared to 3.5% among those meeting the expected standard. Moreover, the overall absence rate of pupils not meeting the expected standard was higher than among those meeting the higher standard (4.7% compared to 2.7%). At KS4, pupils not achieving grade 9 to 4 in English and maths had an overall absence

rate of 8.8%, compared to 5.2% among those achieving grade 41. The overall absence rate of pupils not achieving grade 9 to 4 was over twice as high as those achieving grade 9 to 5 (8.8% compared to 3.7%)

For the most vulnerable pupils, regular attendance is also an important protective factor and the best opportunity for needs to be identified and support provided. Research has shown associations between regular absence from school and a number of extra-familial harms. This includes crime (90% of young offenders had been persistently absent)³ and serious violence (83% of knife possession offenders had been persistently absent in at least 1 of the 5 years of study)

4. Working Together to Improve Attendance

Successfully treating the root causes of absence and removing barriers to attendance, at home, in school or more broadly requires schools and local partners to work collaboratively with, not against families. All partners should work together to:

EXPECT

Aspire to high standards of attendance from all pupils and parents and build a culture where all can, and want to, be in school and ready to learn by prioritising attendance improvement across the school.



MONITOR

Rigorously use attendance data to identify patterns of poor attendance (at individual and cohort level) as soon as possible so all parties can work together to resolve them before they become entrenched.



LISTEN AND UNDERSTAND

When a pattern is spotted, discuss with pupils and parents to listen to understand barriers to attendance and agree how all partners can work together to resolve them.



FACILITATE SUPPORT

Remove barriers in school and help pupils and parents to access the support they need to overcome the barriers outside of school. This might include an early help or whole family plan where absence is a symptom of wider issues.



FORMALISE SUPPORT

Where absence persists and voluntary support is not working or not being engaged with, partners should work together to explain the consequences clearly and ensure support is also in place to enable families to respond. Depending on the circumstances this may include formalising support through a parenting contract or education supervision order.



ENFORCE

Where all other avenues have been exhausted and support is not working or not being engaged with, enforce attendance through statutory intervention or prosecution to protect the pupil's right to an education.

5. Expectations of Plymouth CAST Schools

All schools have a continuing responsibility to proactively manage and improve attendance across their school community. Attendance is the essential foundation to positive outcomes for all pupils and should therefore be seen as everyone's responsibility in school.

The most effective schools consistently promote the benefits of good attendance at school, set high expectations for every pupil, communicate those expectations clearly and consistently to pupils and parents, systematically analyse their data to identify patterns to target their improvement efforts, and work effectively with the local authority and other local partners to overcome barriers to attendance. They also recognise that attendance cannot be seen in isolation and that the foundation to good attendance is a calm, orderly, safe and supportive environment in which all pupils want to attend and can learn and thrive. To manage and improve attendance effectively, all schools are expected to:

- Develop and maintain a whole school culture that promotes the benefits of high attendance.
- Have a clear school attendance policy which all staff, pupils and parents understand.
- Accurately complete admission and, with the exception of schools where all pupils are boarders, attendance registers and have effective day to day processes in place to follow-up absence.
- Regularly monitor and analyse attendance and absence data to identify pupils or cohorts that require support with their attendance and put effective strategies in place
- Build strong relationships with families, listen to and understand barriers to attendance and work with families to remove them.
- Share information and work collaboratively with other schools in the area, local authorities, and other partners when absence is at risk of becoming persistent or severe.

6. Develop and Maintain a Whole-School Culture that Promotes the Benefits of High Attendance

Good attendance is a learned behaviour, and the most effective schools recognise the importance of developing good patterns of attendance from the outset.

Schools that have good attendance recognise that it is not a discrete piece of work but rather it is an integral part of the school's ethos and culture.

In building a culture of good school attendance, all Plymouth CAST schools are expected to:

- Recognise the importance of good attendance and, alongside good behaviour, make it a central part of the school's vision, values, ethos, and day to day life.
- Recognise the interplay between attendance and wider school improvement efforts, building it into strategies on attainment, behaviour, bullying, special educational needs support, supporting pupils with medical conditions or disabilities, safeguarding, wellbeing, and support for disadvantaged students (including use of pupil premium).
- Recognise improving attendance is a school leadership issue and have a designated senior leader with overall responsibility for championing and improving attendance in school. Responsibilities should include offering a clear vision for attendance improvement, evaluating and monitoring expectations and processes, oversight of data analysis, and communicating messages to pupils and parents.
- Make sure all teaching and non-teaching staff know the importance of good attendance, are consistent in their communication with pupils and parents, and receive the training and professional development they need.
- Make sure attendance support and improvement is appropriately resourced, including where applicable through effective use of pupil premium funding. Where possible this should include attendance or pastoral support staff (either school based or contracted) who can work with families, conduct home visits and work in partnership with school leaders, the local authority's School Attendance Support Team and other partners.

- Set high expectations for the attendance and punctuality of all pupils and communicate these regularly to pupils and parents through all available channels. In doing so, schools should help parents to understand what is expected of them and why attendance is important to their child's attainment, wellbeing, and wider development. It should also include clarity on the short- and long-term consequences of poor attendance.
- Visibly demonstrate the benefits of good attendance throughout school life. This may include in displays, assemblies or in registration periods. Where used sensitively and without discrimination, this may also include praising and rewarding improvements in attendance at year group, class/form and individual level.
- Recognise that attendance is never 'solved' and is a continuous process by regularly reviewing and updating messages, processes, and strategies.
- Recognise children missing education can act as a vital warning sign to a range of safeguarding issues including neglect, sexual abuse and child sexual and criminal exploitation.

7. Aims

We are committed to meeting our obligation with regards to school attendance through our whole-school culture and ethos that values good attendance, including:

- Promoting good attendance
- Reducing absence, including persistent and severe absence
- Ensuring every pupil has access to the full-time education to which they are entitled
- Acting early to address patterns of absence
- Building strong relationships with families to ensure pupils have the support in place to attend school

We will also promote and support punctuality in attending lessons.

8. Legislation and guidance

9. Roles and responsibilities

9.1 The Board of Directors

The Trust Board of Directors is responsible for:

- Setting high expectations of all SELT leaders, school leaders, staff, pupils and parents
- Making sure school leaders fulfil expectations and statutory duties, including:
 - Making sure the schools record attendance accurately in the register, and share the required information with the DfE and local authority
 - Making sure the schools work effectively with local partners to help remove barriers to attendance, and keep them informed regarding specific pupils, where appropriate
- Recognising and promoting the importance of school attendance across the trust's policies and ethos
- Making sure the schools' attendance management processes are delivered effectively, and that consistent support is provided for pupils who need it most by prioritising staff and resources
- Making sure the trust and its schools have high aspirations for all pupils, but adapt processes and support to pupils' individual needs
- Regularly reviewing and challenging trust attendance data
- Working with trust/ leaders to set goals or areas of focus for attendance and providing support and challenge
- Monitoring attendance figures for the trust and repeatedly evaluating the effectiveness of the trust's processes and improvement efforts to make sure they are meeting pupils' needs
- Where schools are struggling with attendance, ensuring that trust leaders support school leaders to develop comprehensive action plans to improve attendance
- Making sure all staff receive adequate training on attendance as part of the regular continued professional development offer, so that staff understand:
 - The importance of good attendance
 - That absence is almost always a symptom of wider issues
 - The school's legal requirements for keeping registers
 - The school's strategies and procedures for tracking, following up on and improving attendance, including working with partners and keeping them informed regarding specific pupils, where appropriate
- Making sure dedicated training is provided to staff with a specific attendance function in their role, including in interpreting and analysing attendance data
- Ensuring the sharing of effective practice on attendance management and improvement across the schools
- Holding the headteacher Director of Education to account for the implementation of this policy
- Promoting the importance of pupil attendance across trust policies, practice and ethos
- Ensuring that a member of the Senior Executive Leadership Team has responsibility for attendance
- Ensuring that the Senior Executive Leadership Team and school leaders have the necessary resources to prioritise pupil attendance
- Ensuring that the Senior Executive Leadership Team prioritises attendance, and works with school leaders to improve pupil attendance

- Ensuring that the Senior Executive Leadership Team expects and enables school leaders to fulfil expectations and statutory duties.
- Regularly reviewing and challenging trust attendance data
- Monitoring the impact of trust-wide attendance initiatives
- Holding the Senior Executive Leadership Team to account for the implementation of this policy
- Through the Education and Standards Committee of the Board, regularly receive and challenge whole-trust attendance information, including data analysis.

9.2 Senior Executive Leadership Team

The Senior Executive Leadership Team is responsible for:

- Developing trust attendance policy on behalf of the board of Directors
- Promoting the importance of pupil attendance across trust policies, practice and culture
- Ensuring that school leaders have the necessary resources to prioritise pupil attendance
- Prioritising attendance, and working with school leaders to improve pupil attendance
- Supporting and challenging school leaders to fulfil expectations and statutory duties, including working with their local authority attendance teams.
- Regularly reviewing and challenging trust attendance data
- Monitoring the impact of trust-wide attendance initiatives
- Holding headteachers to account for the implementation of this policy
- Reporting on trust attendance to the Board of Directors
- Reporting on trust attendance to the DfE Regional Director and other agencies as required

9.3 Local CAST Board

The Local CAST Board is responsible for:

- Challenging and supporting school leaders to effectively implement the Trust Attendance Policy
- Setting high expectations of all school leaders, staff, pupils and parents
- Making sure school leaders fulfil expectations and statutory duties, including:
 - o Making sure the school records attendance accurately in the register, and shares the required information with the DfE and local authority
 - o Making sure the school works effectively with trust officers and local partners to help remove barriers to attendance, and keeps them informed regarding specific pupils, where appropriate
- Recognising and promoting the importance of school attendance across the school's policies and ethos
- Making sure the school's attendance management processes are delivered effectively, and that consistent support is provided for pupils who need it most by prioritising staff and resources
- Making sure the school has high aspirations for all pupils, but adapts processes and support to pupils' individual needs
- Regularly reviewing and challenging attendance data and helping school leaders focus improvement efforts on individual pupils or cohorts who need it most

- Working with school leaders to set goals or areas of focus for attendance and providing support and challenge
- Monitoring attendance figures for the whole school and repeatedly evaluating the effectiveness of the school's processes and improvement efforts to make sure they are meeting pupils needs
- Where the school is struggling with attendance, working with school leaders to develop a comprehensive action plan to improve attendance
- Making sure all staff receive adequate training on attendance as part of the regular continued professional development offer, so that staff understand:
 - o The importance of good attendance
 - o That absence is almost always a symptom of wider issues
 - o The school's legal requirements for keeping registers
 - o The school's strategies and procedures for tracking, following up on and improving attendance, including working with partners and keeping them informed regarding specific pupils, where appropriate
- Making sure dedicated training is provided to staff with a specific attendance function in their role, including in interpreting and analysing attendance data
- Sharing effective practice on attendance management and improvement across trust schools
- Holding the headteacher to account for the implementation of this policy

9.4 The headteacher The headteacher is responsible for:

- Promoting the importance of pupil attendance across school policies, practice and culture
- Implementation of this policy at the school
- Ensuring that the school has a designated senior leader responsible for attendance (also known as the attendance champion)
- Communicating the school's high expectations for attendance and punctuality regularly to pupils and parents through all available channels
- Ensuring that the school effectively maintains and supports all required information management systems
- Monitoring school-level absence data and regularly and effectively reporting it to the Local CAST Board (LCB) and trust officers.
- Supporting staff with monitoring the attendance of individual pupils and specific groups
- Working with the parents of pupils with special educational needs and/or disabilities (SEND) to develop specific support approaches for attendance for pupils with SEND, including where school transport is regularly being missed, and where pupils with SEND face in-school barriers
- Communicating with the local authority when a pupil with an education, health and care (EHC) plan has falling attendance, or where there are barriers to attendance that relate to the pupil's needs
- Monitoring the impact of any implemented attendance strategies
- Ensuring that the school works effectively with the local authority attendance team and other agencies to improve pupil attendance
- Issuing fixed-penalty notices, where necessary and/or authorising the school attendance officer to be able to do so

9.5 The designated senior leader responsible for attendance

The designated senior leader (also known as the 'senior attendance champion') is responsible for:

- Leading, championing and improving attendance across the school
- Setting a clear vision for improving and maintaining good attendance
- Evaluating and monitoring expectations and processes
- Having a strong grasp of absence data and oversight of absence data analysis
- Regularly monitoring and evaluating progress in attendance
- Establishing and maintaining effective systems for tackling absence, and making sure they are followed by all staff
- Liaising with pupils, parents/carers and external agencies, where needed
- Building close and productive relationships with parents to discuss and tackle attendance issues
- Creating intervention or reintegration plans in partnership with pupils and their parents/carers
- Delivering targeted intervention and support to pupils and families

9.6 The attendance officer

The school attendance officer is responsible for:

- Monitoring and analysing attendance data (see section 7)
- Benchmarking attendance data to identify areas of focus for improvement
- Providing regular attendance reports to school staff and reporting concerns about attendance to the designated senior leader responsible for attendance and the headteacher
- Working with education welfare officers to tackle persistent absence
- Advising the headteacher when to issue fixed-penalty notices

9.7 The Special Educational Needs Coordinator (SENCo)

The SENCo is responsible for:

- Championing the attendance of children with SEND
- Working with the Designated Senior Leader for Attendance to support the attendance of children with SEND.
- Monitoring and analysing attendance data for children with SENCo (see section 7)
- Working with relevant school staff to support the attendance of children with SEND
- Working with children SEND to identify and address barriers to school attendance

- Working with the parents of children with SEND to identify and address barriers to school attendance
- Working with outside and specialist agencies to identify and address barriers to school attendance

9.8 The Designated Safeguarding Lead (DSL)

The DSL is responsible for:

- Championing the attendance of vulnerable children including those on Early Help, Child in Need and Child Protection Plans
- Working with the Designated Senior Leader for Attendance to support the attendance of vulnerable children
- Monitoring and analysing attendance data for vulnerable children
- Working with relevant school staff to support the attendance of vulnerable children
- Working with vulnerable to identify and address barriers to school attendance for children with SEND
- Working with the parents of vulnerable children to identify and address barriers to school attendance
- Working with the local authority, outside and specialist agencies to identify and address barriers to school attendance for vulnerable children

9.9 The Designated Teacher for Looked After Children

The Designated Teacher for Looked After Children is responsible for:

- Championing the attendance of children in Local Authority Care
- Working with the Designated Senior Leader for Attendance to support the attendance of children in Local Authority Care
- Working with the Headteacher of the Virtual School to support the attendance of children in Local Authority Care
- Monitoring and analysing attendance data for children in local authority Care (see section 7)
- Working with relevant school staff to support the attendance of children in local authority care
- Working with children in local authority care to identify and address barriers to school attendance
- Working with the parents/guardians of children in local authority care to identify and address barriers to school attendance
- Working with outside and specialist agencies to identify and address barriers to school attendance

9.10 The Designated Teacher for Disadvantaged Children

The Designated Teacher for Disadvantaged Children is responsible for:

- Championing the attendance of disadvantaged children

- Working with the Designated Senior Leader for Attendance to support the attendance of disadvantaged children
- Monitoring and analysing attendance data for disadvantaged children (see section 7)
- Working with relevant school staff to support the attendance of disadvantaged children
- Working with children in local authority to identify and address barriers to school attendance
- Working with the parents of disadvantaged children to identify and address barriers to school attendance
- Working with outside and specialist agencies to identify and address barriers to school attendance

9.11 Class teachers

Class teachers/form tutors] are responsible for:

- Promoting the importance of high levels of pupil attendance
- Championing the attendance of children in their class(es)
- Implementing school attendance policy, including policy for managing lesson transitions and arrivals
- Recording attendance on a daily basis, using the correct codes, and submitting this information to the school office twice daily
- Knowing the attendance of pupils within their teaching/tutor groups
- Knowing the attendance of pupils within their sphere of leadership i.e. SEND, PP, LAC etc
- Working with pupils, parents, other school staff and outside agencies to support high levels of attendance.
- Working with the designated senior lead for attendance and other school leaders to support the good attendance of individual pupils and specific groups.

9.12 School staff

School staff will:

- Promote the importance of high levels of pupil attendance
- Take calls from parents/carers about absence on a day-to-day basis and record it on the school system
- Transfer calls from parents/carers to the headteacher and pastoral lead in order to provide them with more detailed support on attendance
- Advise the designated senior lead for attendance of any concerns

9.13 Parents/carers

Parents/carers are expected to:

- Where this policy refers to a parent, it refers to the adult the school and/or local authority decides is most appropriate to work with, including:

- All natural parents, whether they are married or not
- All those who have parental responsibility for a child or young person
- Those who have day-to-day responsibility for the child (i.e. lives with and looks after them)

Parents are expected to:

- Make sure their child attends every day on time
- Call the school to report their child's absence before 8.45 am on the day of the absence and each subsequent day of absence), and advise when they are expected to return
- Provide the school with more than 1 emergency contact number for their child
- Ensure that, where possible, appointments for their child are made outside of the school day
- Keep to any attendance contracts that they make with the school and/or local authority
- Seek support, where necessary, for maintaining good attendance, by contacting the Headteacher, Pastoral Lead or Attendance lead (details above)

9.14 Pupils

Pupils are expected to:

- Attend school every day on time

10. Recording attendance

10.1 Attendance register

We will keep an electronic attendance register, and place all pupils onto this register.

Entries will be preserved by the school for 6 years.

We will take our attendance register at the start of the first session of each school day and once during the second session. It will mark, using the appropriate national attendance and absence codes from the School Attendance (Pupil Registration) (England) Regulations 2024, whether every pupil is:

- Present
- Attending an approved off-site educational activity
- Absent
- Unable to attend due to exceptional circumstances

Any amendment to the attendance register will include:

- The original entry
- The amended entry
- The reason for the amendment
- The date on which the amendment was made
- The name and position of the person who made the amendment

See Appendix 4 for the DfE attendance codes.

We will also record:

- Whether the absence is authorised or not
- The nature of the activity, where a pupil is attending an approved educational activity
- The nature of circumstances, where a pupil is unable to attend due to exceptional circumstances

We will keep every entry on the attendance register for 6 years after the date on which the entry was made.

The school day starts at 8.35 and ends at 3.15.

Pupils must arrive in school by 8.45 on each school day.

The register for the first session will be taken at 8.45 and will be kept open until 9.00. The register for the second session will be taken at 12.45 (KS1) and 1.15 (KS2) and will be kept open until 1pm and 1.30pm respectively.

10.2 Unplanned absence

The pupil's parent must notify the school of the reason for the absence on the first day of an unplanned absence by 8.45am or as soon as practically possible, by calling the school staff, who can be contacted via admin@olota.uk 01803 613095.

We will mark absence due to physical or mental illness as authorised, unless the school has a genuine concern about the authenticity of the illness.

Where the absence is longer than 5 days, or there are doubts about the authenticity of the illness, the school will ask for medical evidence, such as a doctor's note, prescription, appointment card or other appropriate form of evidence. We will not ask for medical evidence unnecessarily.

If the school is not satisfied about the authenticity of the illness, the absence will be recorded as unauthorised and parents will be notified of this in advance.

10.3 Planned absence

Attending a medical or dental appointment will be counted as authorised as long as the pupil's parent notifies the school in advance of the appointment.

However, we encourage parents to make medical and dental appointments out of school hours where possible. Where this is not possible, the pupil should be out of school for the minimum amount of time necessary.

The pupil's parent must also apply for other types of term-time absence as far in advance as possible of the requested absence. Go to section 11 to find out which term-time absences the school can authorise.

10.4 Lateness and punctuality

A pupil who arrives late:

- Before the register has closed will be marked as late, using the appropriate code
- After the register has closed will be marked as absent, using the appropriate code

10.5 Following up unexplained absence

Where any pupil we expect to attend school does not attend, or stops attending, without reason, the school will:

- Call the pupil's parent on the morning of the first day of unexplained absence to ascertain the reason. If the school cannot reach any of the pupil's emergency contacts, the school may contact Children's services or the police.
- Identify whether the absence is approved or not
- Identify the correct attendance code to use and input it as soon as the reason for absence is ascertained – this will be no later than 5 working days after the session(s) for which the pupil was absent
- Call the parent on each day that the absence continues without explanation, to make sure proper safeguarding action is taken where necessary. If absence continues, the school will consider involving an education welfare officer
- Where relevant, report the unexplained absence to the pupil's youth offending team officer
- Where appropriate, offer support to the pupil and/or their parents to improve attendance
- Identify whether the pupil needs support from wider partners, as quickly as possible, and make the necessary referrals
- Where support is not appropriate, not successful, or not engaged with: a notice to improve or penalty notice will be issued.

10.6 Reporting to parents/carers

The school will regularly inform parents (see definition of 'parent', as used in this policy, in section 3.7 above) about their child's attendance and absence levels via letters, texts and Parent Meetings.

11. Authorised and unauthorised absence

11.1 Approval for term-time absence

The headteacher will allow pupils to be absent from the school site for certain educational activities, or to attend other schools or settings.

The headteacher will only grant a **leave of absence** to a pupil during term time if the request meets the specific circumstances set out in the [2024 school attendance regulations](#). These circumstances are:

- Taking part in a regulated performance, or regulated employment abroad
- Attending an interview
- Study leave
- A temporary, time-limited part-time timetable
- Exceptional circumstances
- A leave of absence is granted at the headteacher's discretion, including the length of time the pupil is authorised to be absent for.
- We define 'exceptional circumstances' as a situation that is unusual, rare, and significantly different from what normally happens, often serious enough that ordinary rules, expectations, or procedures may need to be adjusted.
- Leave of absence will not be granted for a pupil to take part in protest activity during school hours.
- As a leave of absence will only be granted in exceptional circumstances, it is unlikely a leave of absence will be granted for the purposes of a family holiday.
- The school considers each application for term-time absence individually, taking into account the specific facts, circumstances and relevant background context behind the request.
- Any request should be submitted as soon as it is anticipated and, where possible, at least three days before the absence, and in accordance with any leave of absence request form, accessible via the school office. The headteacher may require evidence to support any request for leave of absence.

Other valid reasons for **authorised absence** include (but are not limited to):

- Illness (including mental-health illness) and medical/dental appointments (see sections 4.2 and 4.3 for more detail)

- Religious observance – where the day is exclusively set apart for religious observance by the religious body to which the pupil's parent(s) belong(s). If necessary, the school will seek advice from the parent's religious body to confirm whether the day is set apart
- Parent(s) travelling for occupational purposes – this covers Roma, English and Welsh gypsies, Irish and Scottish travellers, showmen (fairground people) and circus people, bargees (occupational boat dwellers) and new travellers. Absence may be authorised only when a traveller family is known to be travelling for occupational purposes and has agreed this with the school, but it is not known whether the pupil is attending educational provision
- If the pupil is currently suspended or excluded from school (and no alternative provision has been made)

Other reasons the school may allow a pupil to be absent from the school site, which are not classified as absences, include (but are not limited to):

- Attending an offsite approved educational activity, sporting activity or visit or trip arranged by the school
- Attending another school at which the pupil is also registered (dual registration)
- Attending provision arranged by the local authority
- Attending work experience
- If there is any other unavoidable cause for the pupil not to attend school, such as disruption to travel caused by an emergency, a lack of access arrangements, or because the school premises are closed

11.2 Sanctions

Our school will make use of the full range of potential sanctions – including, but not limited to, those listed below – to tackle poor attendance. Decisions will be made on an individual, case-by-case basis.

Penalty notices

The headteacher (or someone authorised by them), local authority or the police can fine parents for the unauthorised absence of their child from school, where the child is of compulsory school age, by issuing a penalty notice.

If the school issues a penalty notice, it will check with the local authority before doing so, and send it a copy of any penalty notice issued.

Before issuing a penalty notice, the school will consider the individual case, including:

- Whether the national threshold for considering a penalty notice has been met (**10 sessions of unauthorised absence in a rolling period of 10 school weeks**)
- Whether a penalty notice is the best available tool to improve attendance for that pupil
- Whether further support, a notice to improve or another legal intervention would be a more appropriate solution
- Whether any obligations that the school has under the Equality Act 2010 make issuing a penalty notice inappropriate

Each parent who is liable for the pupil's offence(s) can be issued with a penalty notice, but this will usually only be the parent/parents who allowed the absence.

The payment must be made directly to the local authority, regardless of who issues the notice. If the payment has not been made after 28 days, the local authority can decide whether to prosecute or withdraw the notice.

If issued with a **first** penalty notice, the parent must pay £80 within 21 days, or £160 within 28 days.

If a **second** penalty notice is issued to the same parent in respect of the same pupil, the parent must pay £160 if paid within 28 days.

A **third** penalty notice cannot be issued to the same parent in respect of the same child within 3 years of the date of the issue of the first penalty notice. In a case where the national threshold is met for a third time within those 3 years, alternative action will be taken instead.

A penalty notice may also be issued where parents allow their child to be present in a public place during school hours without reasonable justification, during the first 5 days of a suspension or exclusion (where the school has notified the parents that the pupil must not be present in a public place on that day). These penalty notices are not included in the National Framework, not subject to the same considerations about support being provided, and do not count towards the limit as part of the escalation process.

In these cases, the parent must pay £60 within 21 days, or £120.

Notices to improve

If the national threshold has been met and support is appropriate, but parents do not engage with offers of support, the school may offer a notice to improve to give parents a final chance to engage with support.

Notices to improve will be issued in line with processes set out in the local code of conduct for the local authority area in which the pupil attends school.

They will include:

- Details of the pupil's attendance record and of the offences
- The benefits of regular attendance and the duty of parents under [section 7 of the Education Act 1996](#)
- Details of the support provided so far
- Opportunities for further support, or to access previously provided support that was not engaged with
- A clear warning that a penalty notice may be issued if attendance doesn't improve within the improvement period, along with details of what sufficient improvement looks like, which will be decided on a case-by-case basis
- A clear timeframe of between 3 and 6 weeks for the improvement period
- The grounds on which a penalty notice may be issued before the end of the improvement period

12. Strategies for promoting attendance

Good attendance will be celebrated via texts and parent meetings.

13. Supporting pupils who are absent or returning to school

13.1 Pupils absent due to complex barriers to attendance

13.2 Pupils absent due to mental or physical ill health or SEND

Our Approach to Supporting Pupils Absent Due to Ill Health or SEND

We are committed to ensuring that every pupil—regardless of mental or physical ill health or their special educational needs and disabilities (SEND)—remains connected to learning, feels valued, and is supported to thrive. Our approach is rooted in compassion, partnership with families, and a commitment to removing barriers so that every child can flourish.

Working in Partnership with Families

We recognise that families know their children best. When a pupil is absent due to health or SEND-related needs, we:

- Maintain regular, sensitive communication with parents and carers to understand the child's needs and circumstances.
- Agree together on the most appropriate level of contact, balancing support with respect for the family's situation.
- Involve relevant professionals—such as the SENDCo, pastoral staff, medical practitioners, or external agencies—where appropriate and with parental consent.
- Provide clear information about available support, expected next steps, and any adjustments we can offer.
- Ensure families feel heard, respected, and included in all decision-making.

Adjustments the School May Make

We adapt provision flexibly to meet each child's needs. Adjustments may include:

Curriculum & Learning

- Providing personalised work packs or online learning tailored to the child's capacity.
- Offering reduced or flexible timetables where appropriate and agreed with families.
- Prioritising core learning and essential routines to reduce overwhelm.
- Using alternative formats (visuals, simplified text, audio explanations) to support access.

Environment & Routines

- Gradual reintegration plans to support a successful return to school.
- Safe spaces or quiet areas for pupils who need sensory or emotional regulation.
- Adjusted expectations around homework, deadlines, or assessments.
- Additional movement breaks, rest periods, or medical care routines.

Attendance & Monitoring

- Recording absence accurately and sensitively, following statutory guidance.
- Using attendance meetings as supportive conversations—not punitive ones.
- Ensuring pupils are not disadvantaged academically or pastorically due to unavoidable absence.

Additional Support We Provide

We offer a range of pastoral, academic, and SEND support to ensure continuity of care:

Pastoral Support

- Regular check-ins from a trusted adult to maintain connection and belonging.
- Emotional support through pastoral staff, ELSA, or wellbeing mentors.

- Signposting families to external mental health or medical services where appropriate.

SEND Support

- SENDCo involvement in planning provision, adjustments, and reintegration.
- Updated pupil passports, risk assessments, or individual support plans.
- Access to specialist resources, interventions, or therapies where available.

Academic Support

- Differentiated learning tasks that reflect the child's current capacity.
- Opportunities to revisit missed learning through small-group or 1:1 support, on return.
- Close liaison between class teachers and families to ensure continuity.

Where a pupil has an education health and care (EHC) plan and their attendance falls, or the school becomes aware of barriers to attendance that are related to the pupil's needs, the school will inform the local authority.

13.3 Pupils returning to school after a lengthy or unavoidable period of absence

We recognise that returning to school after a prolonged absence—whether due to illness, SEND needs, family circumstances, or other unavoidable reasons—can be both positive and challenging for pupils and their families. Our approach is rooted in dignity, partnership, and a commitment to ensuring every child feels safe, **welcomed, and ready to learn**

Working in Partnership with Families

A successful reintegration begins with strong relationships. We:

- Contact families early to understand the reasons for absence and any ongoing needs.
- Hold a supportive reintegration meeting (in person or by phone) to agree on the next steps.
- Listen carefully to the child's and family's views, worries, and hopes.
- Work collaboratively with external professionals where appropriate (e.g., medical teams, SEND specialists, social care).
- Provide clear, consistent communication so families feel informed and reassured.

Planning a Personalised Reintegration Pathway

Every child's situation is unique. We tailor reintegration plans to meet individual needs, which may include:

Flexible Timetabling

- A phased return, gradually increasing time in school.
- Adjusted start/finish times to reduce anxiety or fatigue.
- Prioritising key subjects or familiar routines initially.

Curriculum & Learning Adjustments

- Reduced workload or adapted tasks to prevent overwhelm.
- Opportunities to revisit missed learning through small-group or 1:1 support.
- Visual supports, simplified instructions, or alternative formats for pupils with SEND.

Environmental & Pastoral Adjustments

- Access to a safe, quiet space for regulation or rest.
- A named trusted adult for check-ins and emotional support.
- Social reintegration support, such as buddy systems or structured play.

Supporting the Child's Emotional Wellbeing

We understand that long absences can affect confidence, friendships, and sense of belonging. To support this, we:

- Provide gentle, predictable routines to rebuild security.
- Offer pastoral support through class teachers, ELSA, or wellbeing staff.
- Monitor the child's emotional presentation and respond promptly to concerns.
- Celebrate small steps and successes to rebuild confidence and motivation.

Ensuring Academic Continuity

We aim to help pupils re-engage with learning without pressure or judgement. Our approach includes:

- Assessing where the child is academically in a low-stakes, supportive way.
- Providing targeted catch-up support where needed.
- Ensuring teachers understand the child's needs and any agreed adjustments.

Ongoing Review and Adaptation

Reintegration is a process, not a single event. We:

- Review the reintegration plan regularly with the child, family, and staff.
- Adjust support as the child's confidence and stamina grow.
- Maintain open communication so families feel supported throughout.
- Ensure the child's voice remains central to all decisions.

14. Attendance monitoring

We take a proactive, systematic approach to monitoring attendance and punctuality because they are essential indicators of pupil wellbeing, safeguarding, and engagement. Our processes ensure that patterns are identified early, support is offered promptly, and every child is given the best chance to thrive.

Daily Monitoring and Recording

We maintain accurate, real-time attendance records through our MIS. Each day:

- Registers are taken promptly at the start of the morning and afternoon sessions.
- Any unexplained absence triggers first-day calling procedures to ensure the child's safety.
- Late arrivals are recorded with the exact time and reason, enabling us to track punctuality concerns.
- Staff are encouraged to report any emerging worries linked to attendance, wellbeing, or safeguarding.

This daily vigilance ensures that no child becomes “invisible” and that concerns are addressed quickly.

Weekly Review and Analysis

Each week, senior leaders, the attendance lead, and the pastoral/SEND team review:

- Individual pupil attendance percentages
- Persistent absence indicators
- Patterns of lateness
- Class, year-group, and whole-school trends
- Any pupils with SEND, medical needs, or vulnerabilities whose attendance requires additional support

This allows us to spot early signs of difficulty—such as a gradual decline, repeated late marks, or subject-specific absence—and intervene before issues escalate.

Half-Termly and Termly Strategic Analysis

At a deeper level, we conduct systematic analysis at least half-termly:

- Comparing attendance across groups (SEND, disadvantaged, EAL, gender, year groups)
- Identifying trends over time, including seasonal patterns
- Reviewing the impact of interventions and support plans
- Monitoring the attendance of pupils with known vulnerabilities or safeguarding concerns
- Evaluating punctuality data to identify families who may need practical or pastoral support

This analysis informs leadership decisions, resource allocation, and targeted support.

Using Data to Drive Early Intervention

Our analysis is not simply numerical—it is relational and purposeful. We use data to:

- Trigger early conversations with families
- Offer support before attendance becomes a safeguarding concern
- Identify barriers such as anxiety, transport issues, medical needs, or unmet SEND
- Put personalised plans in place, including phased returns, pastoral support, or curriculum adjustments
- Work collaboratively with external agencies when needed

We focus on understanding the “story behind the data” so that support is compassionate and effective.

Punctuality Monitoring

Punctuality is monitored with the same level of care:

- Daily late logs allow us to identify patterns (e.g., specific days, siblings, transport issues).
- Pupils with repeated lateness receive supportive check-ins to understand the cause.
- Families are offered practical help, routines guidance, or referrals to external support where appropriate.
- Persistent lateness is escalated in line with our attendance procedures, always with a focus on partnership.

Reporting and Accountability

We ensure transparency and shared responsibility by:

- Providing regular attendance reports to senior leaders and governors
- Sharing key messages and trends with staff so they can support pupils effectively
- Communicating with families about attendance expectations and available support
- Ensuring attendance data informs safeguarding discussions and multi-agency work

This ensures attendance remains a whole-school priority.

14.1 Monitoring attendance

The school will monitor attendance and absence data (including punctuality) half-termly, termly and yearly across the school and at an individual pupil, year group and cohort level.

Specific pupil information will be shared with the DfE on request.

The school has granted the DfE access to its management information system so that daily attendance data can be accessed regularly and securely.

This is a statutory requirement and enables the school to access and analyse its attendance data through the *View Your Education Data* tool. This tool allows the school to monitor pupil level attendance and have access to near real time data to understand trends in attendance patterns.

Data will be collected each term and published at national and local authority level through the DfE's school absence national statistics releases. The underlying school-level absence data is published alongside the national statistics.

The school will benchmark its attendance data at whole school, year group and cohort level against local, regional, and national levels to identify areas of focus for improvement, and share this with the governing board.

14.2 Analysing attendance

The school will:

- Analyse attendance and absence data regularly to identify pupils, groups or cohorts that need additional support with their attendance, and
- Identify pupils whose absences may be a cause for concern, especially those who demonstrate patterns of persistent or severe absence
- Conduct thorough analysis of half-termly, termly, and full-year data to identify patterns and trends
- Look at historic and emerging patterns of attendance and absence, and then develop strategies to address these patterns

14.3 Using data to improve attendance

The school will:

- Develop targeted actions to address patterns of absence (of all severities) of individual pupils, groups or cohorts that it has identified via data analysis
- Provide targeted support to the pupils it has identified whose absences may be a cause for concern, especially those who demonstrate patterns of persistent or severe absence, and their families (see section 14.4 below)
- Provide regular attendance reports to class teachers, to facilitate discussions with pupils and families, and to the governing board and school leaders (including special educational needs co-ordinators, designated safeguarding leads and pupil premium leads)
- Use data to monitor and evaluate the impact of any interventions put in place in order to modify them and inform future strategies
- Share information and work collaboratively with other schools in the area, local authorities and other partners where a pupil's absence is at risk of becoming persistent or severe, including keeping them informed regarding specific pupils, where appropriate

14.4 Reducing persistent and severe absence

Persistent absence is where a pupil misses 10% or more of school, and severe absence is where a pupil misses 50% or more of school. Reducing persistent and severe absence is central to the school's strategy for improving attendance.

The school will:

- Complete a Persistent Absence Action Plan for every persistently absent child

- Complete an In Danger of Becoming Persistently absent action plan for every pupil at risk of becoming so.
- Use attendance data to find patterns and trends of persistent and severe absence
- Consider potential safeguarding issues and, where suspected or present, address them in line with Keeping Children Safe in Education
- Hold regular meetings with the parents of pupils who the school (and/or local authority) considers to be vulnerable or at risk of persistent or severe absence, or who are persistently or severely absent, to:
 - Discuss attendance and engagement at school
 - Listen, and understand barriers to attendance
 - Explain the help that is available
 - Explain the potential consequences of, and sanctions for, persistent and severe absence
 - Review any existing actions or interventions
- Provide access to wider support services to remove the barriers to attendance, in conjunction with the local authority, where relevant
- Consider alternative support that could be put in place to remove any barriers to attendance and re-engage these pupils. In doing so, the school will sensitively consider some of the reasons for absence
- Implement sanctions, where necessary (see section 5.2, above)

15. Monitoring arrangements

This policy will be reviewed as guidance from the local authority and/or DfE is updated, and as a minimum **annually** by the **trust's Director of Education**. At every review, the policy will be approved by the trust's Board of Director's before being provided to the school for personalisation and adoption by the Local CAST Board.
